PLAYING FORMAT

Teams consist of 2 players, with each team match featuring 4 singles matches and 1 doubles match. Each division will have 8 to 10 teams, competing in a giant round-robin format. A preliminary round will be played on Saturday morning to determine the division.

When a team has won 3 matches, the team match is finished. If there are time available, remaining matches may be played if both captains agree. The results will be counted for ratings only.

TEAM AND SEEDING

Each team may have a minimum of 2 players and a maximum of 3 players. Seeding will be based on the rating of the highest 2 players on each team. The toprated player with a rating of more than 400 points than the teammates must play in at least 30% of the matches after the preliminary round. The rating as of 11/17 will be used for seeding.

ENTRY FEES

- Each team is \$450 plus \$10 per player registration fee.
- EARLY ENTRY BONUS! Enter and pay before November 3rd and save \$90 per team!
- Late entries may be accepted with a late fee of \$45.

FRIEND PADDLERS DIVISION (One day option)

This division is designed for participants who want to compete for just one day. It's perfect for recreational players from high-tech companies or groups of friends looking to enjoy some fun, casual competition. Friend Paddler Division is \$240/team plus \$10 per player, your team may choose to play on either Saturday or Sunday at registration. This division has no preliminary round and will start at 12:30 pm.

UNRATED PLAYER

A player's latest league rating may be used for seeding purposes if one doesn't have a tournament rating. Otherwise, an estimated rating from a USATT certified coach can be used and the coach must email info@ttamerica.org. An unrated player may also play at the Friend Paddler Division without any rating.

CANCELLATION

- Entry fees will be fully refunded if an event is cancelled due to insufficient signups.
- A withdrawal request received by Nov 7th is eligible for a refund. Email us at accounting@ttamerica.org to request a refund. A processing fee of \$25 will be deducted from a refund.
